Diagnoses most seen in a post-acute setting are rapidly shifting to a more frail, multi-system involved caseload, with or without the new COVID-19 diagnosis. Efficient identification of critical illness-related deficits and frailty will allow a clinician to perform a more thorough evaluation, develop a more comprehensive plan of care and obtain positive patient outcomes, all of which is necessary from both a payment and care perspective. Knowing what to focus on when evaluating and setting the plan of care will be even more critical in this current environment. This course is centered on providing evidence- based tests and measures to use for evaluations, frameworks for effective care planning to reduce re-hospitalizations and evidence-based interventions for optimal outcomes in treating the complex frail adult in the SNF and Home Health settings.
